All qualifying entries are submitted to the Central Ohio Chapter of the Ohio Credit Union League and the Ohio Credit Union Foundation to be considered for additional scholarships.

Funds are issued in the name of the recipient and the college or institution of higher learning at time of enrollment into that institution.
